#### **President's Letter**

2023 is now quickly fading away after another enjoyable year on our beautiful lakes. Reflecting back on accomplishments in 2023, your TLPOA organization:

- Operated the East Twin aeration system for the 18th straight year to continue reducing the amount of muck in the lake
- Applied herbicide treatments at specific locations in West Twin to control the further expansion of the Eurasian watermilfoil (EWM) invasive species
- Applied phosphorous absorbing material in the East Twin canal to help reduce phosphorus levels in the lake
- Supported the Michigan DNR in a multi-year walleye study started this year in both East and West Twin
- Continued to educate our membership on the value of healthy shoreline management including our continued support of the Albert Township Greenbelt zoning ordinance
- Published four informational newsletters for our membership
- Held several membership social activities

Thanks to your continued membership support, your TLPOA organization remains financially healthy, allowing us to proceed with several new initiatives for 2024. Among these is a more comprehensive water quality testing project on both East and West Twin. The new data produced from this project in conjunction with the data we continue to receive from the Michigan Cooperative Lakes Monitoring Program (CLMP) will provide us valuable insight on the current health of our lakes and help obtain grant funding from the State of Michigan if any corrective actions to improve our lakes are warranted.

Additionally, a program designed to reduce the number of geese on our lakes is now in the planning stages. Increased goose populations have been a problem for many of our lakeshore residents and is a contributing factor for increased phosphorus levels in our lakes. Watch for more details on this project in the spring.

#### In and around the lakes...

- Wendy Huston has given notice that she will resign as TLPOA Treasurer effective January 1, 2024. Colin
  Gibbings, a current Board member, has stepped up to volunteer as treasurer on that date. Many thanks to
  Wendy for her excellent work as treasurer, and to Colin for taking on this important responsibility.
- Every other year, the TLPOA contracts with PLM Lake and Land Management Corp. to do a **vegetation survey** of both lakes. The survey report will list the types and locations of vegetation present in our lakes and use this information to monitor and treat invasive species such as Eurasian watermilfoil (EWM). The cost of the survey is estimated to be \$5,500 and the budgeted cost for EWM treatment for 2024 will be \$6,000.
- The **August general membership meeting** was well attended with approximately 60 members present. If you were unable to attend the membership meeting or would simply like to review the mounds of information presented, please visit the TLPOA website where the presentations have been posted.
- The **Wine and Cheese Party** hosted by Theresa and John Scott on West Twin Lake was a huge success with many TLPOA members in attendance. Background music was provided by the KuffLinKs, courtesy of the Twin Lakes Shores Resort and Smith Realty.

## Who you gonna call? Goose Busters!

After receiving many complaints about the burgeoning goose population around our lakes, the TLPOA Board is in the process of contracting with the Goose Busters company to help decrease the goose population.



To do so, the Board first was required to obtain permission from the townships surrounding East and West Twin Lakes. Albert Township has granted permission and we will be applying for a permit from Charlton Township (which includes a small portion of properties in the northwest corner of West Twin Lake) in early November.

Goose Busters will control the goose population by relocating the geese to the Upper Peninsula or by destroying their nests. Goose Busters is licensed by the State of Michigan Department of Natural Resources.

We all love wild birds, but not the mess they leave behind. These deposits make their way into the lake and increase the phosphorus in the lake, which decreases water quality. Canada Geese can spread parasites and E. coli. In addition, Canada geese are often aggressive.

#### **Bull Elk Sited on West Twin Lake**




We are all grateful Craig Snyder and Mike and Renae Davis had their cameras ready when the north shore of West Twin Lake got a visitor on an early morning in last month.
