### CALL TO ORDER

Meeting Called to Order at 8:30 am.

### APPROVAL OF MINUTES

The Board approved minutes from meeting held February 26, 2022.

### OFFICER REMARKS

Tom C. reviewed letter from Jim Morphey which included suggestion that TLPOA allow advertising in newsletter as means of raising revenue. Brief discussion held. TLPOA has not allowed advertising in newsletter in the past. The current financial status doesn't warrant a need to advertise.

Tom C. mentioned MLSA conference coming up in April, and that he'd try to attend if his schedule permits.

Tom C. asked Dominic regarding use of school café and library. Dominic indicated the library conference room has been reserved for summer meetings and that he exchanged emails with Cyndie Keviet. He needs to follow-up with her to ensure approval for both membership meetings at the school.

Tom C. also indicated that the calendar of events has been updated and will be on web-site.

### NEW BUSINESS

**Wine & Cheese:** Pete & Sue Stephens will be the hosts of the 2022 Wine & Cheese Party. The date will be August 19<sup>th</sup> and will start at 6:00 pm. The format for voting and asking guests to bring two bottles of the same wine will remain the same. The Board to finalize details next meeting.

**May Membership Meeting:** The next membership meeting is scheduled for Saturday, May 28<sup>th</sup> at the Lewiston Elementary School Café. The meeting will follow the business format approach as done in past meetings. Tom C. to speak with Judd on coffee & Donuts. Board Meeting usually follows Membership. Agenda to be finalized for April Board meeting.

**CLMP Results:** a review of the 2021 data of lake monitoring indicated that water clarity and phosphorus levels have improved on East Twin. Discussion indicated likely cause for improvement is a reduction in lake levels.

### OLD BUSINESS

**Membership Drive:** Tom P. indicated a current count of 167 family memberships and 139 Lake Stewards.

**East Twin Phosporus Treatments:** No Update

**Aeration:** Tim M. indicated the aeration system will be cleaned and inspected the week of May 16<sup>th</sup>. Tim will have system turned on prior to this.

**Eurasian Water Milfoil (EWM):** Tom C. indicates we should be on track for 2022 treatment. Contract is signed and he will follow-up with Bre Grabill from PLM to check on status of permits.

**Social Events:** 8-19-2022 is Wine & Cheese. Tom indicated the Chamber of Commerce meets on March 29<sup>th</sup>. Wendy will be attending the meeting and will help determine TLPOA involvement.

**Website Administration:** Tom C. will have February Board Meeting Minutes added to site.

**Newsletter:** Pat indicated next newsletter will be in May, prior to Membership Meeting. She is looking for and welcomes articles and pictures.

**Water Clarity-East Twin:** Improvements in water clarity on East Twin were previously noted during CLMP data discussion.

Dominic indicated a member brought to our attention the tag line on the newsletter address letters contained an error. Tom P. indicated future labels will read "check your label" to determine status of dues.

Pete discussed the signage for the heritage trail which is a DDA project. There was a discussion on whether or not TLPOA should donate. The amount for a dedicated sign is \$1500. There will be a sign at the East Twin beach. A ceremony is planned at the beach for May 28<sup>th</sup> to unveil a sign. Further discussion to be held at April Board meeting.
