I hope you join us for an hour or so at our annual TLPOA Membership Meeting at the Lewiston School on Saturday, May 27 at 9:00 a.m. where in addition to this walleye monitoring program, we have a lot of new information to share. I'm certain this will be more than worth your time. Come a little early for free coffee and donuts and a time for meeting with friends and neighbors.


DNR Denies MI National Guard Petition for 162,000 Acres, but leaves door open to 52,000 acres.

After hearing from thousands of residents, more than 60 governmental organizations, and Tribal governments, the Michigan Department of Natural Resources (DNR) denied a proposed 20-year lease of an additional 162,000 acres of state forest lands to the Department of Military and Veterans Affairs (DMVA). Instead, 52,000 acres with be available to the DMVA, if they apply for special use permits, use the same process open to others, and pay any fees or costs associated with the permit.

A Memorandum of Understanding (MOA) between the DNR and the DMVA was signed in late April and will be in effect for five years. The MOA states:

- only the amount of land needed for military training will be permitted.
- all areas permitted will still be open to legal public and Tribal use during the time of the permit.
- military training exercises are not allowed in sensitive habitat areas or within 3,000 feet (previously 1,500 feet) of any inland lakes or designated trout streams.
- any State land must be maintained in the condition they existed prior to military use.
- military activities **can include** small formation activity involving less than 500 National Guard members and up to 100 affiliated party members, controlled trials of cyber and electronic warfare technologies, and low impact light maneuver training
- military activities **can not include l**ive fire, loud conduct, use of any materials known to contain PFAS, use of tanks, fencing or any permanent structure, significant damage to vegetation

Some opponents of the original expansion proposal continue to oppose even a limited expansion of the existing 148,000 acres Camp Grayling currently occupies. They cite the 70,000 acres currently within Camp Grayling's footprint that are not currently utilized and concerns about the military's ability to remediate current PFAS contamination.




Storm Water Collection System to be Studied

For many years, your TLPOA Board has been concerned about the storm water collection system from the downtown Lewiston business district that flows into a retention pond south of the post office and then subsequently into East Twin Lake.

After a joint meeting with the Albert Township Board of Supervisors, the Montmorency County Road Commission, and the Huron Pines non-profit environmental organization, the TLPOA Board has decided to proceed with a storm water assessment of the district and its effect on East Twin Lake.

The initial phase of the study will be funded by TLPOA. Any further actions resulting of this review will be subject to much discussion and input from all parties. A formal assessment will be needed before any course of action can be determined.

The TLPOA Board feels that supporting this approach it will be of great benefit to the lake community, especially if grant funding to help improve this situation is to be pursued in the future.



May Membership Meeting



The cold Michigan winter months require boaters to protect boats with covers that are often single-use, bulky, and difficult to manage during disposal. Disposing of these covers in a landfill has a huge environmental impact, as manufacturing with virgin materials requires more natural resource consumption. Recycling can make a big difference. For every bag of material recycled through the Recycle Run program, we save 115 kWh of energy, 13.5 gallons of oil, and 20 cubic feet of landfill space!

Before the Recycle Run program, throwing out boat covers was essentially the only option for most boat owners in Michigan. The Recycle Run program has connected a network of partners to make recycling boat covers easy, accessible, and efficient for anyone in the state. The Recycle Run program has been active for over 10 years, and we continue to work hard to grow and strengthen the program every year.

Boat covers collected through the Recycle Run program are recycled into roofing and decking materials, plastic bags, and even more boat covers.

As boaters, it is important that we do everything we can to keep our waters beautiful and plasticfree. In 2022, we recycled 95,500 pounds of boat covers, keeping those materials out of the waste stream and giving them a productive second life. Our Lewiston lake community is fortunate to have a convenient local drop-off location for filled shrink wrap receptacle bags at the Twin Lakes Marina. If you need fewer than 5 receptacle bags, and would like to participate, here's how:

- Call Dr. Shrink, manufacturer of the receptacle bags, at (800) 968-5147 to order your bags. Each bag comes with a zip tie to seal the bag, along with instructions on how remove your boat covers. Bags are industrial-size and can hold covers from up to a 32-foot boat (1 large cover or 1 to 3 small covers). Each bag costs \$7 plus approximately \$10 for shipping via USPS.
- Uncover your boat and place only the shrink wrap in the receptacle bag to keep it clean and dry. Cut off any buckles, straps, etc. Prepping the shrink wrap for recycling is easy. - 3. Take the filled receptacle bag to the Twin Lakes Marina.
- 4. You're done! Thanks for recycling, saving landfill space, and providing materials for reuse.
